# What is the National Carer Strategy



The Australian Government is working on a plan about **carers**.

A carer is someone who helps look after someone without being paid.




A carer could be a

- Family member
- Friend.



The plan is called the **National Carer Strategy**.

We call it the Strategy for short.



Lots of people will work on the Strategy together to make things better for carers.

- Have good lives




• Reach their goals.

Goals are things you want to do.



Have everything they need to be good carers.





This makes it easier to work on.

Vision

A vision is the big goal that we want to make happen.



Part 2

Principles

Principles are **rules** that we think are important for the Strategy to help carers.

• Objectives

Objectives are things that we **want to** happen.



Part 4

• Priority outcome areas

Priority outcome areas are the things that are most important to make better.

- How we check the plan is working.



The government will make an **action plan**.

The Action plan is a plan that tells people all the things the government need to do.



We want to work with carers to

- Decide on more actions
- Write an **Outcomes framework**.



The Outcomes Framework is our way to **check** that we are doing what we said.

It tells us to **write reports** about what we have done.

It will also help us decide on **more actions** in the future.

### What we know about carers



Lots of people are carers in Australia.



We **need to know** more about carers to help them in the right way.



There has been **research** about carers.

Research means

- Finding out what people think about things
- Using the information to help others.



Research tells us we need more information about



 Aboriginal and Torres Strait Islander carers



 Carers who speak languages other than English



• LGBTQIA+ carers.



Not everyone knows they are a carer.

Not all carers want people to know they care for someone.



This means they might **not** know what help they can get.

# Why are carers important



We know carers are important.



Carers have lots of good skills.

This could help them get a job.



Carers do lots of work that keep people out of

- Hospitals
- Aged care.



We will need more carers as people get older.



Carers sometimes **give up** things for themselves to help the person they care for. Like

• Having a job



Going to school or training



• Going out to do fun things



Giving up things that provides them money.



This might make it hard for carers to have a happy and healthy

- Body
- Mind.

This will mean they can balance their lives with their caring role.
